

[Bitcoin.com](https://bitcoin.com) December to Remember \$20,000 Buy-Raffle Giveaway 2021 Terms and Conditions

1. Sponsor: The Sponsor of [Bitcoin.com](https://bitcoin.com) A December to Remember \$20,000 Buy-Raffle Giveaway is [Bitcoin.com](https://bitcoin.com).
2. [Bitcoin.com](https://bitcoin.com) A December to Remember \$20,000 Buy-Raffle Giveaway (the “Sweepstakes”) is open worldwide, and is void where prohibited by law. Employees, independent contractors, interns, officers, directors, and agents of [Bitcoin.com](https://bitcoin.com) (the “Sponsor”) their respective affiliates, subsidiaries, advertising and promotion agencies, suppliers and their immediate family members and/or those living in the same household of each are not eligible to participate in the Sweepstakes. The Sweepstakes is subject to all applicable federal, state and local laws and regulations. Void where prohibited.
3. 6. Winner Selection and Notification: Winners are selected at by Random Draw under the supervision of the Sponsor. Winners will be notified on January 5, 2022 via the email address registered with our payment processor. In this email, winners will be asked to select between BTC, BCH, and ETH as the payout method and to provide a valid BTC, BCH, or ETH address to receive the payout. To be eligible, winners must provide this information via the provided Google survey by 11:59PM UTC January 12, 2022. Please note, [Bitcoin.com](https://bitcoin.com) will not ask for personal information. The Sponsor shall have no liability for a Winner’s failure to receive notices due to spam, junk e-mail or other security settings or for a Winner’s provision of incorrect or otherwise non-functioning contact information. If the Winner cannot be contacted by 11:59PM UTC January 12, 2022, is ineligible, or fails to claim the prize by 11:59PM UTC January 12, 2022, the prize may be forfeited. Receipt of the prize offered in this Campaign by the Winner is conditioned upon compliance with any and all federal, state, and local laws and regulations.
